1. DEFINITIONS.

SOFTWARE refers to the Activity Gateway™ database design template as provided by Marin Research, Inc.

Note: This design template physically contains two companion applications designated as "HyperGraph" and "Freemind" that are **NOT** part of the Marin Research, Inc. Software. These two components are distributed under the terms of the General Public License (GPL and LGPL). The source code and license agreements for these components are provided within the design template.

4. GRANT OF LICENSE. (1) In return for payment of the license fee, Marin Research, Inc. grants CUSTOMER a license to use ONE database derived from the SOFTWARE. (2) Customer shall have the right to create replicas of this database. (3) Customer shall be allowed to create a reasonable number of backup copies of such database, but these must be used solely for backup purposes and scheduled agents in such databases must be disabled. (4) The specific database may be replaced if lost or corrupted.

6. COPYRIGHT. The SOFTWARE is owned by Marin Research, Inc. and is protected by United States copyright laws and international treaty provisions.

7. OTHER RESTRICTIONS. You may not rent or lease the software, but you may transfer your rights under this license agreement on a permanent basis provided you transfer this License Agreement, the SOFTWARE, retaining no copies, and the recipient agrees to the terms of this agreement. You may not reverse engineer, decompile, or disassemble the SOFTWARE. If the SOFTWARE is an update, any transfer must include the update and all prior versions.

8. LIMITED WARRANTY. Marin Research, Inc. warrants that the SOFTWARE will perform substantially in accordance with the accompanying written materials for a period of 90 days from the date of receipt. Any implied warranties on the SOFTWARE are limited to ninety (90) days. Some states do not allow the limitation on duration of an implied warranty, so the above limitation may not apply to you.

9. CUSTOMER REMEDIES. Marin Research, Inc.'s entire liability and your exclusive remedy shall be, at Marin Research, Inc.'s option, either (a) the return of the price paid or (b) the repair or replacement of the SOFTWARE that does not meet the Limited Warranty and that is returned to Marin Research, Inc. Any replacement of the SOFTWARE will be warranted for the remainder of the original warranty period or thirty (30) days, whichever is longer.

10. NO OTHER WARRANTIES. Marin Research, Inc. disclaims any other warranties, either express or implied, including but not limited to implied warranties of merchantability and fitness for a particular purpose, with respect to the SOFTWARE and the accompanying written materials. This limited warranty gives you specific legal rights. You may have others, which vary from state to state.

11. NO LIABILITY FOR CONSEQUENTIAL DAMAGES. In no event shall Marin Research, Inc., or its suppliers be liable for any damages whatsoever (including, without limitation, damages from loss of business profits, business interruption, loss of business information, or other pecuniary loss) arising out of the use or inability to use this Marin Research, Inc. product, even if Marin Research, Inc. has been advised of the possibility of such damages. Because some states do not allow the exclusion or limitation of liability for consequential or incidental damages, the above limitation may not apply to you.

13. SUPPORT. Marin Research, Inc. will provide email technical support and software updates to the customers' DESIGNATED SUPPORT CONTACT free of charge for a period of 3 months from date of purchase. After the initial three month period, additional support may be offered by Marin Research, Inc. at an annual fee.
